7.1 Importing Construction Materials

- 1 Construction Materials Import and Production Approval Application completed form.
- 2 Copy of product specification documents provided by the manufacturer.
- 3 Copy of documents that validate the country of origin of the product.
- 4 Copy of Customs Registration Certificate provided to the applicant.
- 5 Copy of the test reports or test certificates of the products no older than 2 years.
(The report or certificate that show that the imported products are tested as per approved standards and issued by the manufacturer or a registered third party)
- 6 Copy of the Contractor Registration certificate under Contractor Regulation (C.R) and registered under SY category
- 7 Copy of the manufacturer's licence provided by the relevant organization of the country
(Manufacturer should be registered under an accountable organization of the country)

7.2 Production of Construction Materials

- 1 Construction Materials Import and Production Approval Application completed form
- 2 Copy of the Contractor Registration certificate under Contractor Regulation (C.R) and registered under CM category
- 3 Copy of the test reports or test certificates of the products no older than 2 years
(The report or certificate that show that the products are tested as per approved standards and issued by a registered third party)
- 4 Copy of product specification documents

8. Other Information

- i) The application will be processed by the Ministry if all the documents required are submitted for the approval of the imported materials or produced materials.
- ii) If the required documents are not submitted, or the form is not completely filled, the application will not be accepted.
- iii) Product Approval Certificate will be given separately for each category for each manufacturer for one (1) year.
- iv) If the documents submitted for the approval are in a language other than English or Dhivehi, the documents should be translated to English or Dhivehi and translation & original should be submitted to the Ministry
- v) The applicant is recommended to submit application prior to shipment of materials to Maldives.
- vi) The applicant should apply for renewal of Product Approval Certificate one month prior to the expiration of the Product Approval Certificate.
